Subject: The upcoming hearing and the planning stage
 Good evening Doc,

As hard as I tried to get you the information concerning the quashing of the restraining orders and re-establishing a nurturing relationship with my children on the 13th of March, I could not get through to you through the BlackWallOfNonCommunication. I hope you have succeeded in sending Mrs. Lee the communiqué you promised. I finally sent an email to Chas to relay the proper address to you at his earliest convenience and contact with you. I hope the address was relayed to you properly and you have finally sent the letter you promised to send about a year ago.

I decided that it would be best for me to create some space between me and Clyman/Estep/Langfield and others who seem bent upon fouling my probation before the clock tolls the final hour. Since traveling by automobile presents such a grave danger to me, due to the slanderous "jacket" placed upon me by Gary Clyman and the Colorado State Attorney General's Office, I have taken an alternate way to Albuquerque to seek political asylum until the hearing of 8 April, 2004. Rely on me to be there, in Division 2 Jefferson County Court, with all the support I can muster at 9:30AM. Please let me know if anything changes.

Frank, I trust that all warrants are quashed and that I am not in violation of any unknown agreement. If there is any problem, you can contact me via email or at Pamela's.

Doc, if there is anything I need to be aware of, or prepare for, please contact me by email because my phone does not work here and Pamela is extremely terrified of you and Judith and does not want you to know her address or phone number for fear of what additional damage you two may perpetrate upon her. I appreciate your consideration of her great fear of you and what she believes are the horrible deeds you have done, and may continue to do, to her. As I have demonstrated in the past many times, I will do what I can to intercede for you and limit your liability and mend fences as best I can. Please don't make any more threats toward anyone, it is very difficult to mitigate how people perceive those threats, and your service to me, paid by the STATE is not yet complete, let alone those legal duties that I have paid forward and in advance that you have promised me. It is important to me that you do not create any more problems and liabilities that may effect your ability to assist me in the legal duties you have promised in payment for my two years of professional and indentured service to you. I trust that you will comprehend the importance of your good behavior for the next few weeks.

Chas, it is always easy to communicate with you, since we are internet literate, so if any one in Colorado has need of communication with me, please convert their needs to electrons and I'll get right on it. I'll check email often during this next few weeks. Doc's resistance to electronic communication may prove to be a deadly liability in the ensuing weeks, so I hope you will take him under your wing, as I have for the last two years, and help him to communicate with me in the only manner possible under the circumstances. Pamela is absolutely terrified of Doc and Judith and will not come to my hearing . . . period. She has some very valid concerns about his drinking, abuse and anger that I can't honestly convince her are not a real and present danger to her life and welfare. I realize that many of Doc's clients that I have brought to him share her trepidation, but I'd like for you to explain to them how important is is for them to attend the hearing on 4-8-2004 for my sake. I have spoken to a few that don't want to be in his presence, but it is important that they show support for me and there isn't much he can do to them now.

Doc, we can address these issues after my hearing on the 8th of April, since I was present for many, but not all, of the events they describe in support of their fears of you and Judith.

Chas and Frank, please understand that this communication issue has nothing to do with either of you. It is Doc and Judith that people are in deathly fear of. Since we normally communicate via email I hope this will not cause any problems and you can relay information to Doc whenever he emerges from behind the BLACKwallOfNONcommunication and perceives a need for information. My laptop is live and well and I can communicate from virtually anywhere.

Thank you all for your kind consideration and support in this perilous time. Doc's last message to me was that "my life depends upon it." So I cannot underestimate the danger of which he speaks.
