Greetings all:

I departed my home tonight at 6:24 P.M. on my bicycle enroute to the King Soopers on Evans, near Federal. As I left my home, I noticed a silver Chrysler automobile parked across the street from my driveway. I proceeded North past the Godbey residence and turned East on Iliff Street. I immediately observed Carlos Bonilla walking in the middle of Iliff with cell phone in hand and appeared to be engaged in a conversation. I passed within 10 feet of him and kept on riding until he turned the corner at the Godbey residence and proceeded Southward. I turned around and parked on the curb next to the Corrigan residence and observed Carlos Bonilla enter the silver Chrysler automobile which then immediately backed out to the West into the street and turned around and headed in the opposite direction - Southward. I immediately called Attorney Thomas C. Miller, Esquire and reported the event. He informed me that no further action on my part would be necessary, however, I believe that my best interests will be served by reporting this incident to as many interested or concerned parties as possible since my "probation" stipulates no contact with Carlos Bonilla and other

government informants and agents provocateurs working in conspiracy with Donald L. Estep, Mark Hostlaw, Kurtis Maleri, Marlene Langfield, Dave Thomas, Dennis Hall, Joe Gilmore and Gary Clyman.
